Awards: Ribbons awarded to 6th place in each class/division.

**On-line Entries** via Equestrian Entries at <u>https://equestrianentries.com/</u> are prefered.

**Mail Entries**: Entry form and Coggins should be mailed to show secretary with checks payable to *Indiana Dressage Society*.

**Coggins**: Negative Coggins required for all horses within 12 months of show date. Name on Coggins must match the name of the horse on the entry form.

**Complete entries must be received by the closing date**. Each entry must be signed by the rider, owner of horse, trainer and parent if applicable. Entries will be accepted in the order received until the show is full, then entries are added to the waitlist. Failure to submit a complete entry may result in being placed on the waitlist. IDS Members will have priority on the waitlist.

**Confirmation & Ride Times:** Will be available on <u>https://www.indianadressage.org/</u> three days prior to show date. Times will be <u>tentative</u> and may change. Check the Day Sheet posted at the show for <u>confirmed</u> ride times.

**Concessions:** To be determined.

**Attire**: Show attire is recommended for riders. Braiding the horse is optional. *ASTM approved helmets with fastened chinstrap must be worn by all riders at all times.* 

**COVID Action Plan:** This competition will follow the <u>USEF COVID-19 Action Plan</u>. Masks are required for any person who is not fully vaccinated for COVID.

**Dogs:** Dogs must be leashed at all times while on the show grounds.

**Non-Compete Horses:** Non-compete horses must have a valid entry, Coggins, and pay Office Fee plus either Stabling or Haul-in Fee.

**Camping:** Campsites include 30A electric and water may be reserved on the entry form.

**Bedding**: Bedding can be ordered with your entry for \$8/bag. Bags will be in your stall when you arrive.

**Stall Stripping:** The Hoosier Horse Park requires you strip your horse's stall and pile used bedding 1' outside the stall door upon departure. You may pay the optional \$40 stall stripping fee if you'd like to have your stall stripped by IDS after the show.

**Trash:** HHP removed most blue trash barrels near the stabling. Please dispose of trash in dumpsters.

**Refunds:** Full refund minus office fee prior to closing date. Waitlist Entries: full refund if not accepted.

**Classes**: Current USDF/USEF/FEI/WDAA tests will be used. Classes will be run in 20m x 60m rings unless stated otherwise. The show will be conducted under USEF rules unless otherwise noted by show management. Show management reserves the right to limit entries, limit the classes per horse, to add, divide, combine or cancel classes or make whatever changes required by circumstances of the competition.
