Three scores of 62% or higher at Third Level or above from three different, or any combination of these requirements would also meet the requirements to enter Part 2. Only scores from USEF-licensed/USDF-recognized competition(s) will count.

Cancellation policy: 100% Refund given up to 69 days prior to Session A. 50% Refund given 30 to 68 days prior to Session A. No refund given within 29 days of Session A. If a qualitfied candidate is available to replace you, a refund can be considered. Price list follows this application.
